INSURANCE FACILITIES:

Andhra Pradesh Group Life Insurance (APGLI)

1. The government employees who are between 21 and 53 years of age are eligible to buy a APGLI policy. In case of maturity of the policy the total sum of assured and bonus till date of maturity are paid to the policyholder. In case of disease of policyholder before maturity of the policy the sum assured along with the bonus till date of death are paid to the legal heirs.

2. APSE Group Insurance Scheme (GIS)

AP state employees group Insurance Scheme is introduced with effect from 1-11-1984.

The monthly contribution:

Group A = Rs. 120

Group B = Rs. 60

Group C = Rs. 30

Group D = Rs. 15

On retirement the total accumulation of saving fund with interest will be paid.

On death (a) Lumpsum amount of insured fund will be paid, (b) Total accumulation of a savings Fund with interest will be paid.

3. AP General Provident Fund(GPF):

The general provident fund came into effect on 1st April 1935 giving an extra benefit saving for Government employees, and an employee who is termed under permanent AP state government rules is eligible to contribute for GPF fund and their funds get saved till the maturity period and can check every year in the form of GPF.

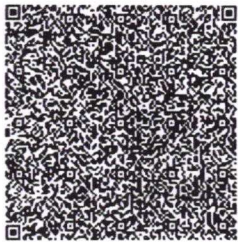
